Noviatiate Land Bus Tour has been tentatively rescheduled for September 12 at 2 p.m.

**Open Space Committee** is reactivated. The first meeting was set for June 21 at 8 p.m. Anyone interested was invited to come along to survey some south side land suitable for open space on June 22, 9:15 - 12: 15. Capital Improvement Lands to be included. The Open space Committee will draft a statement about Norumbega.

Letter to Growth Policy Committee (Newton): Joan Lerner raised the question of the propriety of chairman of Growth Policy committee being a developer (Oscar Wasserman) with a hearing pending concerning a petition for a zoning change for Nahanton St. land now on Conservation Commission's Land Acquisition Catalogue. She drafted a letter, which the Board amended and APPROVED. It will be sent to the membership of the Growth Policy committee and to the local newspapers.

It was MOVED, SECONDED and APPROVED that a statement from the Newton Conservators be presented at the June 29 hearing of the Conservation Commission. The Open Space Committee is to draft it. **Environmental Space Program**: Scott Saroff reported that ESP has not met its quota of 36 students. Rather, 15 students have been enrolled, 12 of whom are fully paid. The staff has stripped the budget to bare essentials; cuts include small bus trips and the Boston Harbor trip. Two more scholarships are sought. The Conservators agreed to stand behind ESP in the event of a deficit. (A deficit of \$150 is a possibility.) Conservators are invited to come along on trips and attend staff workshops.

<u>Ordway Park</u>: It was MOVED, SECONDED and APPROVED to pay \$664 for the plaque at Ordway Park. Helen Heyn reported that the Collegiate Labor Force charges \$5/hr. They could pick up trash and do light pruning with supervision by Roesner and Heyn. Jim Pines is willing to begin work on the stone path in August at \$10/hr.

It was MOVED SECONDED and PASSED to spend \$40 for the Collegiate Labor Force for work during July and August at Ordway Park.

Discussion of <u>remuneration of Conservators for Conservators' projects</u>. The question was raised by Richard Staley, whose employment by ESP predates the Conservators involvement with ESP. He was interested in guidelines for the future.

A MOTION was made that the spirit of the bylaws be interpreted as meaning that no directors shall receive remuneration for any service rendered to Conservators. The motion was TABLED until the next meeting.

**Environmental Science Program report**. A calendar was distributed and corrections made. The scholarship appeal made through the newsletter has been successful. There was much praise for students in the program. There was discussion of the desirability of the Conservators' having insurance coverage for ESP next year, possibly as a rider on a possible policy (liability and property damage) for Ordway Park. Several people agreed to research the matter.

**Open Space Committee Report**. Joan Lerner and Cay Morrison are co-chairmen of the committee. A history of the committee was given, beginning with its inception in 1973. The desirability of the development of a city park on the **Novitiate land**, which would act as a terminus for a Charles River pathway, was discussed. The Conservation Commission should be asked to increase the amount of CIP land in the (presently 15 acres out of 60 for 1979) Novitiate area and to move up the acquisition date.

Since this piece of land is threatened and is #1 of its point list, it will be the focus of the committee's efforts. There followed a discussion of ways to maximize participation in the Sept. 19 tour. On July 28 at 6:30 the committee will walk the land with the Commission. The next Open Space Committee meeting is on the 20th of July at 35 Amherst Rd., Waban. At that time a presentation will be prepared for the Conservation Commission.

President Ann Roesner called the meeting to order and determined that an official quorum was present. She appointed Ed Lerner acting secretary.

Report of the **<u>Nominating Committee</u>**: The following slate was presented and unanimously APPROVED:

Vice President - Abe Bluestone Directors to 1977 - Richard De Santi to 1979 - Lisa Colb to 1970 - Harry Crosby

# Report of the Open Space Committee's progress.

- a) Presentation on Novitiate land made to Conservation Commission.
- b) Tour of Novitiate land given to Julia O'Brien of MDC and Gene Larson, Newton DPW. They had many specific questions and wanted a full, structured proposal, leading the committee to think that creation of a formal proposal was necessary. The committee suggests hiring Bill Giezentanner to work up such a plan.
- c) The Committee wants to withdraw from joint sponsorship with the Newton Conservation Commission of the Sept. 19 Novitiate land tour because the Commission is, at this time, taking a position in opposition to purchase of the land prior to 1979 and is asking for only 15 acres.
- d) Many presentations to other groups local gov't, Oak Hill Park Ass'n, etc. are planned.

The Board VOTED to withdraw from co-sponsoring the Sept. 19 tour.

<u>**Presentation by Bill Giezentanner**</u>: Unlike Norumbega, the choice at the Novitiate land will not be developer's proposal vs. local resistance. The proposal will have various alternatives, according to the amount of land purchased. Copies of his proposal circulated to the Board.

It was MOVED, SECONDED and unanimously PASSED by the Board that up to \$750 be authorized for Phases 1 and 2 of the 3 Phase proposal.

It was MOVED, SECONDED and unanimously PASSED by the Board that a fund be established to cover expenses for pursuing and acquisition of the Novitiate land. Source of funding is to be worked out.

**Report of the Environmental Science Program for the Summer of 1976** (by Scott Saroff): All of the 16 participants were of much higher quality than in years past. The program had a new surplus of \$150, which will be set aside to print and distribute flyers next summer. Printed copies of the activity report were distributed. Scott Saroff will probably not return next summer; he'd like to recruit a replacement from the Newton Junior High faculty.

The Environmental Science wants to run a monthly lecture series in Newton on environmental topics. For Sept. 20 they have lined up an expert on environmental medicine and public health. Ann Roesner agreed to find a liaison person who will contact them early in September.

**<u>Report of the Ad Hoc Finance Committee</u>** - Marcus Lieberman, Andree Wilson, Rodney Barker: The by-laws have called for such a committee as a regular function. With major expenses now, an ad hoc committee was set up. The committee presented a set of guidelines for handling funds that was worked up for the committee by Abe Bluestone.

It was MOVED, SECONDED and unanimously PASSED that these guidelines be accepted to be effective immediately. The board further VOTED to transmit this to our banks.

Ann Roesner announced that our accounts are being temporarily held frozen until banks received the new guidelines.

It was MOVED, SECONDED and PASSED that an Auditing committee be appointed (as per Article VIII of bylaws). A committee composed of Marcus Lieberman, Andree Wilson, and Rodney Barker was appointed.

The Ad Hoc committee then suggested that the present treasurer, David Hunt, be asked to resign. It was pointed out that his move to New Hampshire after his election has made easy access to funds and records a problem. The Board went into Executive Session and VOTED. It was decided that we need to have a treasurer living within the city of Newton.

**<u>Report of the Membership Committee</u>** (Grace Taglienti, chairman, Abe Bluestone, Ann Dwelley, Sally Barnett): The Board discussed membership problems. The following suggestions were made:

- a) Publicize family memberships \$10/couple
- b) Active newsletter
- c) Recruiting at Conservator functions (Ann Dwelley reported that the best source of new members in recent years has been the guided walks.)
- d) All new members to be phoned by an officer to recruit them for an active committee.

**The Newsletter**: Harry Crosby agreed to serve with others on the Newsletter. An editor is still to be determined.

These minutes were taken by Ed Lerner.

**Financial Policies** passed by the Board of Directors of the Newton Conservators, Inc. on August 11, 1976.

- A. <u>All</u> Conservator expenditures must be made by check, except for those less than \$10.00 made from designated Petty Cash Funds.
- B, A Petty Cash Fund may be set up under the control of an Officer or Committee Chairman (for example the Secretary or Membership Chairman) to permit small disbursements to made readily. These funds shall operate as follows:
  - (1) Each account must be authorized by the Board for a period not to exceed one year (and thus either lapses or is recreated annually.)

- (2) Such authorization must include the maximum sum transferable to the account (\$50.00 suggested) and the <u>name</u> and position of the person controlling the account.
- (3) Each expenditure must be made on a Petty Cash Withdrawal Form showing date, amount, purpose, recipient, and signature. Wherever possible, receipts should be attached to these voucher forms.
- (4) Requests for replenishment of Petty Cash Funds should be accompanied by records of expenditures (vouchers plus receipts) and should be for the exact amount expended.
- (5) Checks to replenish Petty Cash Funds must be cosigned as described below.
- C All checks or withdrawals from any Conservator account must be cosigned by two of the four Officers: President, Vice-President, Secretary, Treasurer. All signature cards on file at the banks shall lapse after one year.
- D All checks, withdrawals, or transfer of funds from any fiduciary account (Webster, Arboretum, Ordway, etc.) must require, in addition to cosignature, a resolution of the Board signed by the President or Vice-President and the Secretary.
- E A Treasurer's report shall be made, in writing, to the Board at each monthly meeting. Such reports shall be <u>signed</u> and <u>dated</u> and shall include:
  - (1) A statement of balances in all accounts as of the date of the report.

(2) A statement of activity in each account during the month showing amount, purpose, and recipient or source.

- F An annual budget shall be established. This shall be drawn up by the President or Vice-President and the Treasurer, plus such other Directors and Members as may be appropriate, be approved by the Board, and be submitted to the Membership for approval at the Annual Meeting.
- G Any expenditures of more than \$100.00 not covered by the budget must be approved by the Board by resolution as described in Par. D. above.

A MOTION to include in the next minutes a statement of the Financial policies of the Newton Conservators as adopted at the Aug. 11 mtg. was SECONDED and PASSED. It is herein enclosed [see Aug.1976 minutes -- it is enclosed there].

A letter from David Hunt concerning his resignation was received by Secretary Paula Gross and read to the Board, as requested by David Hunt.

A MOTION made to appoint Marcus Lieberman Acting Treasurer and directing him to be in communication with David Hunt was SECONDED and PASSES. He will ask Hunt to go over the books with him and will contact banks for statements.

President Roesner reported that on Aug. 9 a temporary hold was placed on Conservator accounts, resulting in the return of six checks (improper signature), which are now valid if resubmitted.

Members of the board indicated that they would like the treasurer to keep a ledger acct. of funds.

<u>Membership Committee</u>. Chairman Grace Taglienti is resigning. A new chairman is needed (as are people to work on the newsletter). The work of the committee is:

**Open Space Committee**. A presentation concerning the **Novitiate land** was made to the Aldermanic City Planning Committee and also to the 8th ward Democrats, who were enthusiastic.

**Present**: Officers Roesner, Gross, Lieberman; Dirs. Barnett, Wilson, Morrison, Lerner, McKinnell, Cobb.

The meeting began with a discussion of the previous <u>minutes</u>. Correction of Membership List - Gerald Abrams' phone is 965-1697.

<u>**Treasurer's Report</u>**: Distributed. Our treasurer pointed out that as a result of Sally Barnett's letter asking people to renew membership, we have collected \$745 in membership renewal dues for October and November alone.</u>

It was MOVED, SECONDED and PASSED that the treasurer pay \$30 to the Conservation Law Foundation, thus making the Conservators members.

Some legal advice concerning lobbying given to Sally Barnett by Sandra Dawson, a lawyer with the Conservation Law Commission: according to our by-laws we can lobby at the local but not the state level. Other advice concerned the Tax Reform Act, which may affect us locally.

In Jan. we want to form a committee to examine by-laws and to look into the desirability of revisions, particularly in respect to state lobbying limitations. We must also look into a change in the fiscal year.

<u>Membership</u>: a letter to solicit new members will be sent to Audubon members, probably mailed by Audubon. Other possibilities: friends and neighbors, AMC members.

Newsletter: discussion of its contents and mention of A&P purchase cards.

**Open Space Committee**: Giezentanner attended meeting of Steering Committee at Andree Wilson's house. His fact sheet has been looked over and will be placed at local libraries and banks. Crosby thought 4,000 a good figure for (Novitiate) petition signatures. (We have 2,000). To this end Joan Lerner suggested including a petition sheet with newsletter. A discussion of Bob Romero's suggestion to have a stenographer at City Planning Committee hearings was suspended. Slide shows for PTAs were suggested, and letters to the mayor were urged.

<u>Merley Farm</u> - Sally Barnett read a statement she drafted for hearing, a restatement of position taken for Growth Policy Committee. (Petitioners want a zoning change for 196 units.) The statement was approved in principle - Sally and Joan will write a final statement, to be read on the 16th.

In lieu of the regular board meeting, there was a <u>discussion of PUD and cluster zoning</u> with Betsy Klein, planning consultant for Wayland as well as Audubon Society Wetlands Program co-director and member of Cambridge Conservation Commission, and Alexandra\_Dawson of the Weston Conservation Commission and Conservation Law Foundation.

**<u>Present</u>**: Officers Roesner, Bluestone, Gross, Lieberman; Dirs. Crosby, Barnett, Wilson, Morrison, McKinnell, Cobb, Barker, Hague; members T. Bliss and J. Bliss; guests: aldermen Bullwinkle, Jackson, Richmond, Sheehan, Cohen, Stiller, Dietz; state rep. Peter Harrington; Newton director of planning and development C. Thomas; Betsy Klein and Alexandra Dawson.

Betsey Klein spoke about her experience in helping the town of Wayland formulate its ordinance. The zoning applies to 5 parcels of land over 125 acres. There was much public interest and effort in the community's consideration of how it would like to see itself grow.

Wayland's objectives

- 1 Preservation of open space
- 2 Ability to conserve certain special areas (environmental, historic, etc.)
- 3 Variety of housing types
- 4 Avoidance of a drain on the tax rate (least important)

Tools to these ends

- 1 Acquisitions
- 2 Revision of cluster provision to render it usable.
- 3 Lincoln's form of cluster development increased density if can add land to town.

Flexibility was stressed and made part of the bylaw. Topography and access to the site need to be allowed for.

<u>Open space</u> - In Wayland one third of the land (in the cluster zoning reg.) is deeded outright to the town. Another third can be held by the developer or owner but the building rights are deeded to the town. There are regulations about access to this land and participation by local officials in planning its use. The Newton bylaw - by contrast does not have enough provision for similar involvement. Also absent is a provision (present in the Wayland regulation) for the developer to pay a fee to be used by the town for consultation.

Alexandra Dawson offered some points of application of Section 9 (cluster ring) Chapter 808 of the new (1975) state zoning act. She spoke if its legal implications and specifications for the control of open space involved.

Some issues raised: A lively question and discussion session ensued. Alderman Sheehan expressed concerns about provision for low-income housing. Alderman Jackson introduced the possibility of PUD making it attractive for golf course owners to sell their land. The current lack of incentive for developers to build single family houses was mentioned. Representative Harrington suggested that Newton needs to consider preservation of open space as opposed to development. He sees development as implicit in the proposed cluster zoning ordinance. Thomas expressed his view that PUD and land acquisition by Newton can proceed side by side.

On April 27 Conservators and others are invited to consider criteria for conservation land acquisition review - by Conservation Commission.

**<u>By-Law Revision</u>**: Dirs. Barker and Romero read the revisions and explained them. Substantive changes affect scope of lobbying and length of board terms.

A MOTION was forwarded, seconded and PASSED to retain the policy of not giving out our membership list (mailing list).

The Open Space Committee will ask Bob LeMere what he would charge to be financial advisor on land acquisition in Newton.
