**Announcement:** Fran Hints reported that Boston University, School of Public Communication, has a program that utilizes services of graduate students to develop public relation plans for non-profit organizations. Details to be reported at next meeting.

**Secretary's Report:** MOTION that the Secretary's report on May 24 meeting be accepted. ACTION: accepted.

**Treasurer's Report:** Attached to June 24 minutes is Treasurer's report on projected income for remainder of 1980 and commitments already made. Treasurer's report for June will be presented at July meeting. Because of the full agenda it was decided to DEFER ACCEPTANCE of the Treasurer's Annual Report and Audit Committee Report until the July meeting.

MOTION: that the "cup" or "trophy" donated by the Newton Conservators to the Commonwealth Country Club be called the "**Lisle Baker Award**" in recognition of Lisle Baker's efforts in acquisition of the golf course land for the City. ACTION: APPROVED. Joan Lerner and Arnold Meltzer will pursue the matter.

**Open Space Plan Committee:** Joan Lerner presented a draft statement (including specific changes) concerning the City's 1980 draft Open Space Plan. The statement was developed by the Conservators Open Space Plan Committee. There are two major deficiencies in the City's plan: (1) It does not deal with large parcels of land (the golf courses) in Newton. (2) No consideration is given to future recreation needs due to the energy crisis. It seems there are no statutory or regulatory requirements for public input into the Plan; but there are guidelines, e.g., the Conservators' statement can be appended to the Plan.

DISCUSSION: It is important that the City protect "spacious" lands. It is important that the City have criteria and a rating system for setting priorities for lands to be kept open. Since 1974 the conservators have had long range plans. They developed a rating system then, surveyed vacant parcels, and set priorities for acquisition and for lands to be kept open. The Conservators recommend that the golf courses should be kept open. There should be contingency plans in the City's Plan in case parcels become available. If there is no mention of a goal of keeping the golf courses open, state or federal funding is more difficult to obtain for such parcels.

Recommendations for additions to the Conservators draft statement: brief history of Conservators Open Space Plan, desirability of evaluating and prioritizing land when developing a Plan, pleasant and safe trails and linkages for pedestrians and bicyclists, accuracy of description in CJP land, inclusion of all of Temple Mishkan Tefila's woods for protection.

The statement should be presented with a cover letter to the Chairman of the Conservation Commission, with a copy to the Planning Director. Letter should specifically ask that points made in the statement be incorporated into the Plan. MOTION: to adopt intact statement prepared by the Conservators Open Space Plan Committee with additions recommended during Board discussion, to be presented at the June 26 Conservation Commission meeting. ACTION: passed unanimously.

**Novitiate update:** Rodney Barker, Peter Harrington, and Russ Halloran will arrange to go over Novitiate property to arrange for parking.

**Commonwealth Country Club update:** voted 22-0 by Board of Aldermen.

**Field Trips:** In early June very little space was left at Auburndale Playground for a Sunday picnic in late August. No reservations were made. A field trip to the Green Power Farm will be arranged for a mid-week evening in late July.

**Report - Chestnut Hill Golf Course.** Mayor Mann has decided to proceed with the acquisition. Suit has been brought by some opposing neighbors contesting the special permit issued by the Board of Aldermen, which may delay the construction of 42 housing units (25 on Algonquin Rd. and 17 on Kenrick Street). The seriousness of the delay has not yet been determined.

**Report on visit to Greenpower Farm,** Weston. It rained the day of the visit to Greenpower Farm so that the physical site visit was limited. The members talked with the farm manager, who is a retired farm owner. He has been managing the farm for the past 10 years. Newton High School students work at the farm during the summer for credits. The food raised at the farm is given away within the inner city. Visiting members were impressed with the scope and size of the project. The manager suggested that such a project could be conducted within the city of Newton. He suggested that a one or two acre farm would be sufficient and that it was not necessary to have large tracts of land.

During general discussion it was suggested that the members consider contacting Jerry Angino to see if he would have any general interest in discussing such a proposal at his farm site or somewhere within the city.

**Report - Lacey Estate.** Lisle Baker is to contact Mr. Lacey to determine his interest in discussing possible and/or probable methods of preserving some or all of his estate, which is located on the easterly side of Winchester Street, as open space.

DISCUSSION: It was discussed and determined by consensus that the agenda for the next board meeting should include a general discussion of **means and methods of**

**protecting open space in the city** of Newton, including proposals to establish various vehicles to protect the open space, such as proposals for establishment of new zones, means of establishing conservation easements, the impact of 100% valuation on open space, estimates of real value of large open space parcels, etc.

**Secretary's Report.** MOTION: That the secretary's report be accepted with correction that annual audit be through December 31 in each year. ACTION: ACCEPTED.

**Report - Chestnut Hill Country Club.** Acquisition by the city is not yet complete. The city needs a survey of the land, which will cost approximately \$10,000.00 and is in the process of negotiating with various parties in an attempt to recover that sum.

**Report - Lacey Estate.** Letter received from Lacey that they are not available at this time to discuss the various methods of preserving open space at or near Winchester Street.

**Committee appointed:** John Bliss, Rodney Barker, Bart Hague, and Ed Lerner are appointed to a committee to establish a proposed plan **to institute and develop a program similar to that conducted by Greenpower Farm in Weston.** It is suggested that they contact Jerry Angino for ideas and advice concerning the parameters and implementation of such a program.

DISCUSSION: The **question of Proposition 2 1/2** (Referenda Question 2 on the November ballot, 1980) was discussed generally. Sally Barnett advised the members present that the League of Women Voters had contacted the Newton Conservators and asked that they publicly support opposition to Question 2, Proposition 2 1/2. After general discussion concerning the by-laws it was determined that it was within the scope of activities of the Newton Conservators to take a position on the question, since passage of the proposal would have a substantial impact on the acquisition and preservation of open space within the city of Newton. MOTION: "Whereas the proposal called Question 2 on the Massachusetts ballot on November 4, 1980, is destructive to the tax resources of Newton and damaging to local fiscal responsibility and control. Whereas the enactment of question 2 would seriously curtail acquisition and maintenance of open space in Newton, Therefore, be it resolved that the Board of the Newton Conservators, Inc. is opposed to Question 2 and urges citizens to vote "no" on Question 2 in November. ACTION: ACCEPTED.

MOTION: To support the efforts of Newton citizens **to maintain the lot on Washington Street and Lewis Terrace as permanent open space.** ACTION: ACCEPTED.

Committee appointed to plan a series of **spring walks** in conjunction with distribution of the map. Appointed: Cay Morrison, Virginia Taplin, Debby Howard, Bart Hague, Jean Thompson.

Committee appointed to explore **possibility of an annual Conservators' Award for "Newton Environmentalist of the Year"** (with accompanying potluck supper). Appointed: Joan Lerner, Harry Crosby, Rodney Barker.

DISCUSSION: by Lisle Baker concerning **vehicles available to Newton to take advantage of opportunity to preserve land now open.** The following vehicles were explained:

- 1) Private agreement between private individual and public authority.
- 2) Zoning ordinance.
- 3) Acquisition of a full or partial interest by the city.

Attending were members of the Conservators' Board of Directors, a team sent by the Marriott Corporation, and a group of Auburndale residents living near the Marriott (some of whom are Conservators).

Presentation of the Marriott proposal was made by Dennis Rieske, the architect, and the Marriott's local attorneys, Jason Rosenberg and Eliot Cohen. They made the following points:

The hotel currently lacks adequate parking, but has been able to attract many more guests than its present rooms can accommodate. They want to expand their accommodations by building a new wing and parking garage, both buildings to be located on the site of the present parking lot. The garage would be a 4-level building, with only the top level above ground.

This would increase their guest rooms from present 433 to a total of 660. (The new wing would only contain guest rooms; they are not planning any new function rooms or exhibit areas.) Parking would increase from 672 cars to 1164 cars. 190 parking spaces are on

the above ground level, but the entrance ramp brings cars in at the bottom level, and they are assuming that most cars will be in the protected underground spaces. The new guest wing would match the existing building architecturally.

Their engineering studies indicate no drainage problems. Construction would all be at levels above aquifers, and the area's geology creates a self-contained basin that would retain all runoff during construction. The garage's own drain system would capture the first 1/2" of rainwater, keeping contaminants from hillside runoff.

During the 4 month (June-September) construction period, the Marriott would need an overflow parking capability of 200 cars. They want to use Norumbega Park's open field for this. It would be valet parking, without hardtop. They would pay \$20,000 a month rent to the city and, after use, would make considerable improvements to the landscaping of the Park. (They spoke of a budget of up to \$250,000 for improvements.) All trees and shrubs removed for construction would be replanted in the Park or elsewhere at the City's choice. The core of their plan for Park development is the plan the Bill Giezentanner drew up for the Conservators.

As part of the total project, a pathway would be created at the river's edge connecting the Marriott property with the Charles River Pathway (which presently goes around the Marriott via Commonwealth Avenue). They are also proposing a boathouse for public use on the river. The river path might be natural, enhanced by wildflower plantings, or a boardwalk along the river. Impact and maintenance issues would have to be negotiated with the MDC

Criticisms of the proposal were offered as running comments by Conservators and in an informal presentation by the neighbors' group. Specific items focused upon the issue of visual effect. They asserted that the new building and garage would noticeably detract from the appearance of the area to people on the river and its banks. Neighbors also rejected the claim that there would be minimal change in existing traffic patterns, and their own visual analysis of increased traffic density in the area, and cited the example of a child struck on a nearby street by a speeding taxi evading the traffic on Commonwealth Ave.

General criticisms of the proposal focused on three topics: (1) the dangerous precedent of agreeing to private use of public land; (2) a long history of broken public promises associated with the arrival and growth of the Marriott (documented in a history prepared by the neighbors); (3) issues related to the impact on the adjoining park and its neighbors by what would have become one of the largest hotels in the Boston area. Critics felt that the area would be seen as a hotel, with a park in its shadow. This image would suggest that Newton does not value its park lands.
