Sally Barnett brought us up to date on happenings at City Hall.

**Program Planning**: Bart Hague presented a broad suggested program for the year. Debbie Howard suggested a five-year planning program, targeting one, possibly two, areas at a time. It was a unanimous CONSENSUS that the Novitiate be our major target now with the Kennard Estate a secondary one.

Some additional suggestions:

1. Appointment of a Program Chairman to schedule walks and outings.
2. Development of a speakers' bureau.
3. Work with CRWA on water outings.
4. Work with Newton Recreation Commission to schedule events of interest to conservationists.
5. Expand membership.
6. Outings for school children working through the Superintendent of Schools.

Resolved: That Board meetings this year will continue to be held, as before, on the third Tuesday of the month.

Resolved: To distribute our **maps** at no charge discriminately to those genuinely interested.

Joan Lerner reported for the **Park Project Committee** and spoke of a "bring your own" **picnic** with all sorts of activities for all ages - bird walk, nature walk, canoeing, children's races - balloons and kites provided by Conservators - remarks by Mayor Mann, Russ Halloran and CJP representative to promote cooperation in the **best use of the Novitiate land**. Carol Morrison indicated the Recreation and Conservation Commissions were pleased to co-sponsor the picnic. Bill Geizentanner will be commissioned to do a map of the area.

A MOTION was made and PASSED to give the Park Project Committee \$500.00 to use, if necessary, for the first Novitiate event and ancillary activities. The date of the picnic will be October 17th with October 24th as the rain date. The next Park Project committee meeting will be at Ed and Joan Lerner's on August 24th.

The remainder of the meeting was devoted to the **Novitiate Park and the picnic** scheduled for Sunday, October 17th (rain date, Oct. 24th).

Joan Lerner gave a detailed description of the variety of activities that will be going on at the picnic (read the yellow brochure distributed at the meeting and included with the Newsletter mailing).

Volunteers are needed to help make the picnic a success. Those of you who did not attend this meeting, please call Joan Lerner, 965-2381. Your assistance is needed and you'll feel good about participating.

Frank Wright spoke of a liaison meeting that was held among representatives of the City, the C.J.P., and Conservators to promote **cooperation in the development of Novitiate Park**. Frank was hopeful about the future of this liaison group. He felt the City and the C.J.P. were receptive to contributing funds toward the improvement of the park if the Conservators put in Emma Quint money. Russ Halloran is going to set up another meeting, which will include "Friends of the Novitiate." Debbie Howard will send a progress report to the Emma Quint Foundation.

Joan Lerner indicated that Sally Barnett will be in charge of the Novitiate winter event.

The Board APPROVED the suggestion that the Newton Parks and Recreation Commissioner should be requested to support the Bottle Bill.

President Hague opened the meeting. The **Secretary's and Treasurer's reports** were approved.

**Jewish Community Housing for the Elderly (J.C.H.E.)** representatives Ellen Feingold, Herman Snyder and Alan Schlessinger presented the plan for building a facility on land owned by C.J.P., which has received a grant from H.U.D. They plan:

1. 100 units and about 30 parking spaces for independent elderly only
2. To buy land from C.J. P. (option on 4.8 acres);
3. Site has been proposed, but transferability an issue;
4. Proximity to community center important;
5. Need a zoning change requiring approval by the Board of Aldermen;
6. Will have a "footprint" on Friday, October 22.

Rodney Barker and Debbie Howard spoke of the unsuitability of siting on C.J.P. land because:

1. It removes elderly from easy access to downtown;
2. Of undesirable pressures on Novitiate Park.

And suggested occupying Warren Junior High School.

J.C.H.E. representatives suggested meeting again with a subcommittee of the Conservators as they left.

Toni Wallace outlined the procedures for obtaining a H.U.D. grant: Proposal is at "Fund Reservation" stage and now plans and specs must be developed and approved. Approval is contingent on the applicant obtaining the necessary local zoning and site plan approvals.

During a special October 7th J.C.H.E. presentation to the Conservators, Alderman Terry Morris, Land Use Committee Chairman, noted that the Board had approved the site plan for the Novitiate only 3 years ago on the basis of appropriate density and expressed concern about maintaining the integrity of the site-plan approval process in the face of incessant pressures to increase density at a site. (Messrs. Barker and Hague, among others, share this concern.)

Peter Harrington, Frank Wright, Lisle Baker and Verne Vance discussed the possibilities of this proposal becoming a reality and suggested we continue discussions with all parties concerned. Joan Lerner wants the Conservators to continue to help to create a Novitiate Park for Newton that would best serve the people of Newton.

The Novitiate Committee will continue to follow the proposal and explore alternative sites and strategies.

The **Secretary's report** of the previous meeting was APPROVED.

An aldermanic committee meeting to hear and consider approval of new **Conservation Commission appointments** will be held at 8:00 pm on Wednesday, December 15th at Newton City Hall. Conservators are encouraged to attend to participate in eliciting comments from nominees to determine their views on conservation.

Bart Hague spoke on the need for the Conservators to establish improved and even institutionalized links to the various **media** -- local newspapers, cable T, etc. -- in order to disseminate news, information on our position on issues in timely and effective fashion. Some members volunteered to participate in this program.

AnnaMaria Abernathy detailed some of the plans in various stages of approval to **"improve" the flow of traffic from Route 128 through Newton via Commonwealth Avenue.** These improvements would destroy, among other things, the "linear park" and various other characteristics of Commonwealth Avenue that make it one of our most attractive boulevards.

A MOTION was PASSED to express in writing to the Newton Traffic Commission the opposition of the Conservators to this program. (The Traffic Commission is having a meeting Tuesday night, December 7th, 7:30 pm, on this matter. Conservators are urged to attend to express their views.)

The remainder of the meeting was devoted to the **Novitiate Park Project**:

1. Cay Morrison described the meeting of the Friends of the Novitiate held at the Brown Junior High School on 11/4/82, well attended by members of the Conservators Board but by only 3 members of the community.
2. Mary Herring described the lively meeting of people in her neighborhood at which many expressed concern about changes in zoning to be requested by the C.J.P. of the Zoning Board for their Novitiate development that would affect property values. Several neighbors felt they had not been kept fully informed by Marcy Richmond. Another neighborhood meeting is planned.
3. During the remainder of the meeting, an attempt was made to develop a consensus in the Conservators position to the C.J.P. plan to obtain approval for 100 units of housing for the elderly. It was agreed that our opposition should include alternatives to the C.J.P. plan that would be more favorable for elderly housing such as the Warren Junior High School. It was also agreed that we should stand firm in opposition to any additional proposals by the C.J.P. that would further change the character of their Novitiate Park development.

A brief discussion of the proposed Novitiate parking lot location indicated that it cannot be seen by Police from the street. It was APPROVED that this should be pointed out to Russ Halloran.

A MOTION was PASSED for the Conservators to retain the services of Bill Giesentanner for an indefinite period of time for the sum of \$1,000.00 to give us advice and guidance on long range plans for the development and usage of the Novitiate Park.

The **Secretary's report** of the previous meeting was APPROVED with the following amendment: "...to appropriate a sum up to \$1,000...for the services of Bill Giesentanner...

**Environmental Science Project.** The Conservators contribute money to this project every year and Ruth HeespeLink pointed that every year we end up giving more than is budgeted. To establish better control over the outlay, Ruth will call Dick Staley who runs the project to determine, in advance, how much money will be needed, so that what is budgeted only will be given.

**Commonwealth Avenue Highway Project.** AnnaMaria Abernathy reported on the meeting of the Traffic Commission to get community input. The Commission, which is an advisory body, recommended that the plans, including the suggestions of the Auburndale community, be approved. Much of the community input was representative of the Conservators' letter to the Commission.

**Novitiate Park - Winter Event.** It was APPROVED to permit the Committee to spend up to \$250.00 for this event. The Conservators are responsible for flyers, publicity, refreshments and ski lessons. Russ Halloran has indicated that the City will do the heavy chores required to make this a successful event. The date for the event will be February 6, 1983, with February 13, 1983 as the alternate date in case there is no snow.

Sally Barnett reported on some recent open space happenings. **Brookline** has transferred to their Conservation Commission thirty acres of **town land abutting the Lost Pond Reservation and Newton's Kennard Reservation**, so that the combined region is now one hundred outstanding conservation acres.

Sally pointed out that a conservation restriction for the **Kessler East** area was recommended in the Conservators' 1974 open space plan. It was the sense of the meeting that it was important to form a committee of people interested in the preservation of this property, which is owned by Boston Edison.

**Newton Plan for Low Income Housing.** Does an overall plan exist? What are its contents? Ginny Taplin volunteered to talk to Eloise Houghton of N.C.D.F. - Newton Community Development Foundation. John Quatrell, Housing Development Coordinator for Newton, will also be contacted. In addition, Verne Vance will endeavor to get a copy of Newton's public housing program. It certainly is important for the Conservators to be familiar with such a plan.

**Award Dinner Committee.** Bart Hague appointed the following to be members of the Committee: Rodney Barker, Peter Harrington, Ginny Taplin and Verne Vance. Others may be added.

**Novitiate Park Project.** Cay Morrison pointed out the need for the Conservators to develop a plan for the Park. Because of a lack of specific goals, we keep reacting to rather than promoting specific programs. Cay felt the presence of Bill Giesentanner in

this project would help considerably in the development of a plan, so that we would take the initiative more frequently in the future.

A meeting of the Conservators with the C.J.P. leadership was scheduled for December 20th at the Golda Meier house library. Several members of the Board and Bill Giesentanner were scheduled to attend. We shall get a report on the proceedings at our next meeting.

**Site Plan Approval Process.** It was felt that the process had some major shortcomings because once a specific plan was approved in detail, the developer often came back to the Board of Aldermen at a later time with changes that, in more instances than not, were accepted and approved. Terry Morris's remark made on another occasion that "Each succeeding Board does not honor the decisions of the previous Board" supported the despair and cynicism felt by many at the meeting. It was the sense of the meeting that the Conservators should join with the League of Women Voters, the Chamber of Commerce and others to form a broad coalition of support for land use planning for the future of Newton.

Frank Wright's Large Parcels Committee will develop an agenda for the next meeting. The next meeting will be held on Tuesday night, January 18, 1983, 7:45 P.M., at AnnaMaria Abernathy's house, 45 Islington Road, Auburndale. Telephone: 244-3447.

A MOTION was made and ACCEPTED to subscribe to the **State Legislative Bulletin on Environmental Issues**.

Bart Hague reported on a meeting held at the Golda Meier House library at which he presented the **Conservators' views before the C.J.P. Board**. They indicated they would respond to our position, but as of this date they hadn't, although prior to the public meeting Mr. Sidman said they would entertain restrictions on development.

At a subsequent Zoning Board meeting, Rodney Barker was able to intervene to delay the decision-making process. Rodney suggested that the Conservators write to the Zoning Board and Land Use Committee expressing our views and thanking them for hearing us and deferring their decision. A MOTION was made and ACCEPTED to that effect.

We are pleased to report that Frank Wright is now a member of the Conservation Commission.

It was recommended that Rick Bone, Executive Director of N.C.D.F., attend one of our future meetings to discuss **long range plans**.

Sally Barnett spoke of the wonderful cooperation she has received from Russ Halloran in planning the **Winter Event at the Novitiate Park**. Much of the preparation and implementation will be done by his department. Brochures were distributed to those in attendance for placement in supermarkets, stores, libraries, etc.

The **Secretary's report** and the **Treasurer's report** were APPROVED.

Sally Barnett, Bart Hague and Stephen Small reported on their visit to the **Lacey Estate**. They observed that their experience reinforced the need for improved land use planning in our City. One important step would be to have those involved in land use planning visually, physically, inspect areas that are under consideration for development. The City Planning Department and the Aldermanic land use committee, who are involved in the decision-making process, should be encouraged to engage in the procedure so that the evaluation of developer plans could be done with a more critical understanding.

Bart Hague appointed a **land use committee** to research means to strengthen the City's land use planning program. Verne Vance suggested that the committee contact communities in the state that are recognized as being in the forefront in good land use planning. Their programs and processes should be evaluated to determine the reasons for their success. Appointed to the committee, which would be a sub-group of the Large Parcels Committee, were Cay Morrison, Mary Herring and AnnaMaria Abernathy.

The Board APPROVED a donation to the **Environmental Science Project** of \$660.00 for this year's program, with the understanding that this will be evaluated annually.

It was decided that material for the **Newsletter** should be sent to Fran Hintsa within the next two weeks.

The **Secretary's and Treasurer's Reports** were APPROVED.

A MOTION to send \$50.00 to Sharon Francis for travel expenses to the Conservators Dinner was APPROVED. Also passed was a MOTION to send a \$25.00 donation to the West Newton Unitarian Church for permitting the use of their facilities for the dinner.

Richard Bohn, the Executive Director of **NCDF**, described the workings of his organization. The NCDF receives requests for housing from all income groups and manages several pieced of property. The first development under their management was Hamlet Street. The second unit was Casselman House, forty three units of housing for the elderly on Sumner Street, right next to the post office. The third development scheduled for NCDF management is the Weeks Junior High School, which will have 67 units for the elderly and 8 family units. Several of these will be subsidized.

Richard Bohn indicated that these properties are acquired through three sources: the City of Newton, private real estate developers, and private institutions. Casselman House, for example, was purchased from the Mutual Bank for Savings on favorable terms. Weeks School was leased from the City, also on excellent terms. Future developments include Warren Junior High School and the Pine Street dump area, also known as the Rumford Avenue Disposal Area.

INTRODUCTION: To outline where we've been and where we're going. To elicit members suggestions and active participation.

## I. PAST AND PROSPECTIVE OPEN SPACE PROGRAM.

### A. PRIORITY GOALS

1. Protect remaining open space heritage - what's left in face of intense development pressures at a time when little public funding. Emphasis on: golf courses, institutional holdings & private parcels. Anticipate and speak out on priority proposals - notably those relating to Conservators' Open Space Program and Newton's Open Space Plan.
2. Strengthen Newton's land use policies to achieve consistency and permanence in open space protection - especially provisions for site plan approvals and zoning, supported by tax policy.

B. PROGRAM: A ROAD MAP to rally neighborhoods, as well as citywide residents, toward protection and use & enjoyment of area wide clusters or nodes of parks, open spaces, and conservation lands. Many interconnected by Charles River Pathway, Charles-to-Charles Corridor, and aqueducts as backbones to system.

### C. FOCUS: THIS PAST YEAR - Novitiate and vicinity

1. Launch planning and neighborhood participation (Friends of Novitiate) to make new Novitiate Park a model of planning and public use & enjoyment. Earmarked substantial part of Emma Quint Foundation grant of \$7,000.
2. Hold four season events: Fall, winter, spring, and upcoming summer.
3. Retain Bill Geizentanner as planner/public participation consultant/doer.
4. Held neighborhood meeting to try to form "Friends of Novitiate" as first in a series throughout Newton (hopefully).
5. Negotiate with CJP Board on joint planning, as well as further development proposals.
6. Intervened actively in CJP's petition to Board of Aldermen and Board of Zoning Appeals to amend original site plan and extend nonconforming use to build 100 units of HUD subsidized housing for the elderly:
  - a. Moved site from Oak Woods.
  - b. Limited height
  - c. Secured conservation restriction on Oak Woods, as a land use policy precedent.
  - d. Obtained informal commitment to joint planning.
