




## **Project Program and Goals**










Project Area Inventory and Analysis – Land Ownership








#### North Area - Two Bridges to Trestle Bridge






#### South Area - Trestle Bridge to Quinobequin Road




Shared-Use Trail **Trail Spur**






#### Walnut Street/ Route 16/ Quinobequin Traffic Study

• No cross walk currently exists



- ADA-compliant ramps



#### **Existing Conditions** – Quinobequin Road


- Shared-use trail proposed on the west side of Quinobequin Road


**Existing Conditions** – Quinobequin Road north of SB on-ramp





#### **Existing Conditions** – Quinobequin Road north of SB on-ramp


- Shared-use trail proposed on the west side of Quinobequin Road

#### **Existing Conditions** – Quinobequin Road looking north/east


- Shared-use trail proposed on the west side of Quinobequin Road
